### **Transit Options for Route 7 Are Focus of November Public Meetings**

**Arlington, VA** – Imagine a bus or rail car that whisks riders along Route 7, getting them to work, school or an appointment in half the time it now takes. Envision Route 7 is setting the stage for that by identifying a new transit service that will provide a more reliable and faster trip for more people. The public is invited to learn more about transit options and share thoughts and ideas about the future of transportation in the Route 7 corridor on November 4, 10 and 18.

Featuring an open house format, the meetings will allow the public to explore the extent to which bus rapid transit or light rail will increase transit use along Route 7 and the cost to provide high-capacity transit service. Research findings pertaining to ridership and cost will be on display as will information about the possible alignments, or routes, for several types of transit, including improved standard bus service.

Envision Route 7 focuses on a 14-mile stretch of road running from Tysons – through Falls Church, Seven Corners, Bailey’s Crossroads and Skyline – to Alexandria. With the number of jobs and residents each expected to rise by more than a third over the next 25 years, improving transportation options in the corridor is of interest to many.

The November meetings are designed to be interactive, providing those in attendance with an opportunity to ask questions and comment on the study. That input will be used to identify a preferred alternative – one that will reduce travel time and move more people through the corridor – in spring 2016.
