

NVTC's Priorities for WMATA:

- ✓ Demonstrate accountability to Virginia's investment
- ✓ Control operating costs (<3% annual growth)
- ✓ Increase system ridership/revenue
 - 1. Maximize use of 8-car trains
 - 2. Improve weekend rail service
 - 3. Develop parking pass products
 - 4. Optimize parking facilities
 - 5. Expand fare products

Since 2017, NVTC has invested \$42M (37 projects) on I-66 commuter projects


- ✓ Taking 8,300 cars off the road daily
- ✓ Connecting 20 activity centers across

 Northern Virginia and the District of Columbia
- ✓ To date, removed 1 million annual hours of delay from commuters
 - Nine new express bus routes
 - Additional service on seven bus routes
 - New Park and Ride Lot
 - Capital Bikeshare near Metro
 - Four county-wide TDM programs
 - ADA/bus stop upgrades
